## Excerpts from the 726th official contact meeting of 12 November 2019

**Ptaah** My observations are **that** very many of the government officials are incapable of carrying out their duties of governance and allow themselves to be influenced by their collaborators, advisers and also by unjustified or simply thoughtless and unobjective demonstrations of the people, because everything that affects them far exceeds the capacity of their intellect. This means that these governmental persons lack the ability and capacity to stimulate the rational use of their thinking, so that they do not know, grasp and understand reality and truth, nor are they able to draw logical conclusions.

These governmental persons of proven or underdeveloped intellect neither allow them to think and reflect in a rational way nor are they able to effectively gain valuable knowledge and insights, because they have neither access to reason nor to reason. Basically they think and act only according to the guidelines of their personal power behaviour, so that mistakes and cross-compliance are unavoidable and the whole of their decisions and actions are no more than ridiculous and, moreover, usually bring harm to the people.

**Billy** This means that they are addicted to stupidity and are unable to govern because they are responsible for their

Governmental activity is incapable of using reason and reason, which is what causes stupidity. Therefore, even clever and clever people with a very good education in any field can be stupid

and be stupid about government work or anything else. And it is precisely in this respect that I am thinking of the majority of German governments, both male and female, who are also influenced by climate protection activists, such as the little naive brat Greta Thunberg and the equally naive Luisa Marie Neubauer, who have no idea what the fundamental origins and all the connections of climate destruction are. In Germany, the Green Party is at the forefront in this respect, but especially Merkel, who has hoisted Karrenbauer to Brussels as Minister of War and von der Leyen as Chief Dictator and long before, with her feeble-minded culture of welcome, irresponsibly lured countless refugees to Europe. In the Mediterranean alone, more than 20,000 refugees have drowned, while criminal smugglers earn millions of dollars. This alone shows that this ugliness of women is absolutely incapable of her office of government - just like the hoisted war minister and the EU dictator as well as the majority of the other female and male mist governments - and would have to be removed from her abused office and drastically punished for it.

**Ptaah** By which you say what I think. Particularly in Germany, France, Austria and in the EU dictatorship stronghold of Brussels, the stupidity and ignorance you have mentioned and declared regarding the basic evil of climate destruction and all other related destructive factors is particularly pronounced among the highest rulers. All their behaviour and actions are effectively the equivalent of ridiculousness on an unprecedented scale. But this is also true of the Green parties concerned and of the people - unfortunately also in your homeland Switzerland - who, in their stupidity and precisely because of their inability to use their intellect and their reason, have no idea, let alone any knowledge, of the reality of the true cause of the entire climate evil. And this entire basic evil is based solely on the fact of the rampant overpopulation, whose destructive machinations on the planet and the entire ecosystem have so affected and diseased the climate and made it a tremendous factor of natural disaster that it can no longer be stopped in the long run.

**Billy** Around the world, the nonsense of international climate demonstrations, the loudness of climatologists and the useless UN climate conferences are taking place again and again, as will be the case in Madrid from 2 to 13 December this year 2019. So all these needs, necessities of life and special wishes, etc. of the earthlings are not less with each individual new earthling during the fixed time for the resolutions fantasized by the climate conferences, but to the contrary, inexorably growing and more comprehensive. But this means that in the old framework of all the destruction, destruction and degeneration of the planet and the ecosystems, there will be further muddling along in relation to the new births, which are increasing at an ever faster rate. As a result of the unstoppable growth of overpopulation, more and more destruction, destruction and degeneration must be carried out to meet the growing needs of an ever-increasing number of earthlings. And if we look at this and consider the fact that millions of these young people who grow up every year are also mobilising again with vehicles that produce CO<sub>2</sub> emissions, then the emissions of these greenhouse gases increase by millions of tonnes. This, while every newborn earthling releases millions more tons of thousandfold toxins and poisonous gases into nature, all ecosystems and the atmosphere, driving the climate catastrophe further and ultimately into collapse. And what has to be said about the vehicles and the crazy phantasmagoria of the fact that the CO<sub>2</sub> problem can be solved if the entire culture of mobility can only be solved with electric vehicles and electric trucks and with electric working machines, then this is effectively a criminal sham. Just the procurement of this necessary energy - whereby this immense procurement of energy resp. production of energy will probably be illusory - would require the construction of countless new energy production plants and power stations and thus also the destruction of an enormous amount of fertile cultivated land. And because the overpopulation is growing inexorably, every single square centimeter of fertile soil would slowly but surely lead to the catastrophe of no longer being able to grow and harvest enough natural food. All these facts - and these are only three of many - are not taken into consideration by the <experts, <bright men and loudmouths of all faons; be it the better-knowers of science, the majority of politicians and their <green> parties, the government, or be it the climate protectors or the hysterical climate demonstrators.

The fact is that the climate crisis will not only affect the earth and humanity in the future, because it started early in the century before last and the last century. Furthermore, an ecological balance is only established in the course of development, whereby all the numerous interlinked material cycles interact and maintain each other, such as the water and nutrient cycle and the carbon and oxygen cycle, which is also necessary. Only in this way can the whole function, prosper and be maintained.

But the enormous overpopulation and its needs - which have been and continue to be met for the satisfaction of mankind through destructive, devastating, exterminating and irresponsible machinations - have not only provoked and brought about climate destruction, but also the now prevailing climate destruction. In the beginning there was some resistance in our group to this, because it seems to border on missionising and it is a great effort, connected with high costs and perhaps no success. However, the group nevertheless began to produce an English-only version of this flyer, which only comprises four A5 pages (two DIN A4 pages) and thus reduced the costs of print-ing to a minimum. And this flyer can now also be printed at home by every passive member without great effort.

In September 2019, my friend Bianca and I finally began our first letter box action, namely in a suburb of Melbourne, where we distributed 800 flyers over two days. The result surprised even us: The statistics of our internet page showed that we roughly had a 20% increase of visitors/hits on the following day! Then in October almost 500 flyers were distributed in Wangaratta, a smaller city in the country, and on the following day again a rise in visitors/hits on our website was noted, however, not quite as big as the previous one.

The results showed us that the letterbox actions are worthwhile, because through them we have reached many more human beings than we do with our information stands. Sure, there would be quite a number of persons who would have thrown the flyers straight into the bin, but nevertheless they would have seen the peace symbol, and we hope that they have absorbed it via their subconsciousnesses and will recognise it again one day when they spot it on our cars, on the posters at our information stands or at other opportunities.

This action has nothing to do with missionising, because we are not pushing the flyer into anyone's hand, trying to make them read it. Every human being, in his/her own four walls, can freely decide whether he/she wants to dispose of the flyer or look at it more closely. If a person has a sticker on their mailbox indicating that they do not want to receive unsolicited mail, we do respect that and skip that mail box. And at our information stands the peace flyer is only recommended if a person asks what they should read to begin with.

## Containment of Russia and China is "a serious mistake of the USA" - Putin

The strategic goal of the USA is to contain Russia and China. According to Russian President Vladimir Putin, however, this is a serious mistake that undermines Washington's positions. "Unfortunately, its goal is not to balance international economic relations - the US itself is speaking publicly about this. Its most important strategic goal is to curb the development of China and Russia. I think this is a very serious, deep-seated mistake that undermines the position of those who initiate this kind of policy," Putin told the Russia Calling Investment Forum on Wednesday.

### Washington must revise relations with Nato allies - Putin

According to Putin, Washington's restrictions on China are not related to the imbalance in the balance of trade. The fact is that the Chinese economy is more efficient.

"I can say with great certainty that this unique phenomenon (the development of the Chinese economy - editor's note) has produced a very good result. The Chinese economy is much more efficient than many other large economies in the world, including the American economy," Putin stressed.



### **Offsetting between Russia and China**

Moreover, Putin considers the increase in settlements between Russia and China in the national Currency for absolutely realistic:

"The stability of the (Chinese - editor's note) currency is obvious, and this of course creates conditions for a more extensive use of yuan in mutual settlements. In this context, I would like to point out that the rouble is a freely convertible currency in Russia, to any extent and at any time. It is very convenient to use."

### **Putin on concern after first anti-Russia sanctions**

The Russian head of state admitted that he was concerned after the first sanctions against Russia, but that the country had achieved great success in substituting imports in various industries.

"A very serious, big step has been taken to strengthen our economic and technological sovereignty. It is in this spirit that all these restrictions have been placed on our economy."

### **Washington's trade dispute with Beijing**

The head of state of the United States has caused numerous trade conflicts. In particular, the dispute with China, which has been simmering since July 2018, is slowing down the global economy. Washington once imposed punitive tariffs of 25 percent on 818 Chinese goods with a total value of 34 billion US dollars. Beijing then announced retaliatory measures. Since then, the two largest economies in the world have been imposing reciprocal special tariffs.

In October, Trump announced that it had agreed on a partial agreement, but it is still unclear when it will be sealed.

Richard Engel is chief foreign correspondent of the US TV station NBC News. His words are broadcast to millions of households in the United States of America and via cable or satellite abroad. He is currently followed on Twitter by over 376,000 people. He was previously stationed in the Middle East as a correspondent, reporting on the wars in Iraq and Syria, for which he was awarded the James Foley Medill Medal for Courage in Journalism. So when Engel has something to say on a foreign policy issue, it certainly carries weight in public discourse.

An often shared tweet from him has now triggered a controversial debate in the USA. Some see these words as confirmation of the criticism of the decision to withdraw US troops from northern Syria - only to use them to occupy oil fields - while others see in them at best an ignorant attitude and at worst complete ignorance of US history. So what did the chief foreign correspondent say that heated up people's minds like that?

The more I talk to sources about this, the more I hear that America's betrayal of the Kurds and the humiliation and 'misogynistic' 'crushing' of the US ambassador in Ukraine for political reasons makes people think that we Americans have become the 'bad guys'. The more I talk talk to sources, the more I'm hearing America's betrayal of the Kurds, and the humiliation, "misogynistic" "squashing" of US ambassador in Ukraine for political motivations makes people think, we, Americans, have become the "bad guys." Hearing it was gut punch.

Whether ignorance or ignorance, both are fed by the same source, which angels here rather involuntarily reveal. He was obviously deeply convinced of the myth of the uniqueness of the USA, of the myth that his country is the "good guys". The "bad guys", or the bad guys, are always the others. That is why he is so surprised that now the United States is suddenly supposed to be the "bad guys". The Brennan Center for Justice has also looked into this issue and concluded that the division of the world along these lines is designed to make an objective assessment of the US approach to the so-called war on terror impossible.

Yet in the current case the USA has not committed any treason, as is now so often claimed. The US troops in Syria were themselves illegal occupying forces, which only secured the rule of the Kurdish Party of the Democratic Union PYD and its militia YPG over this area. Washington has made no promises whatsoever to enable the Kurds to form their own state. What came to light here in an unpleasant way was that the USA only used the Kurds as proxies in the fight against the IS. However, this is neither new nor unique, but corresponds to the practice of the United States since the end of World War II.

### **Betrayal of the Shiites in Iraq 1991**

In fact, however, the USA has betrayed the Shiites in Iraq. Shortly after the start of Operation Desert Storm, the large-scale coalition to expel Iraqi troops from occupied Kuwait, US President George H. W. Bush called on the country's Shiites to rise up against then Iraqi President Saddam Hussein. And indeed, the Shiites dared to revolt when on March 3, a tank commander returning from Kuwait shredded the larger-than-life portrait of "Hitler of Baghdad", as the US government called the Iraqi dictator, with one of his tank grenades in the main square in Basra. They were hoping for US support after Bush had called them to do so and Operation Desert Storm was still in full swing.

US Secretary of State Mike Pompeo admitted during a discussion round at Texas A&M University which methods the USA uses in foreign policy.

But help for the Shiites was not forthcoming. After the advance of the coalition troops on Baghdad was stopped shortly before the capital and against all expectations Saddam Hussein was left in power, it was clear that Shiat Ali was left on its own. And it was to get much worse.

The US Central Command (CENTCOM) under the leadership of General Norman Schwarzkopf Jr., now revered as a war hero, allowed Hussein's cousin, General Ali Hasan al-Majid and his Republican Guard, notorious in the West as "Chemical Ali", to brutally crush the Shiite uprising. In Najaf and Karbala, his troops created a bloodbath, destroyed the holy sites and desecrated the largest cemetery in the world. Tanks were used to cut aisles in the cemetery Wadi as-Salam (Valley of Peace), which had been in use since the seventh century, in order to completely destroy the insurgents who had been cornered there. The Americans also looked the other way when Madjid launched attack helicopters and used them against sparsely armed insurgents in southern Iraq.

According to various estimates, the Iraqi army's massacre of the Shiites cost the lives of about 100,000 people, according to former US diplomat Peter W. Galbraith. Without the call of the US president, however, this uprising would never have taken place. And although the USA thus bears indirect responsibility for this crime committed by Saddam Hussein, the return of the "hero" Norman Schwarzkopf Jr. at the head of a military train of Operation Desert Storm on Broadway in New York was celebrated on June 11, 1991 with the largest military parade since the end of World War II. Five million people cheered the parade, which resembled a modern version of a Roman triumphal procession.

## **Willy Wimmer: When will Germany get a "Ministry of Truth"?**

German universities were considered to be world leaders in terms of freedom of teaching and research. Until, yes, until American conditions in Germany came to an end and the universities had to do everything possible to obtain external funding.

Fear and anxiety are commonplace at German universities. I wonder if the speaker from Hamburg, the Federal President, has ever heard that before?

On Monday, 18 November 2019, Federal President Frank-Walter Steinmeier was in Hamburg/Germany. There he spoke at the annual meeting of the Rectors' Conference of German Universities. That is, where the dilemma for freedom becomes visible. German universities were considered to be world leaders in terms of freedom of teaching and research. Until, yes, until American conditions in Germany came to an end and the universities had to do everything they could to obtain external funding.



Otherwise the chairs were no longer functional. These third-party funds could not be obtained "just for fun", conditions were attached. The system behind it, which can be called perfidious, is well enough described by the name of the young scientist from Switzerland, Dr. Daniele Ganser. His university workplace received funding from another country. The freedom of research and teaching did not suit the foreign donor at all. To this day it is still being propagated that a quite undiplomatic hint was enough to send a hopeful scientist into professional oblivion.

That's how you do it, and that's all there is to it. That's why fear and anxiety are rampant at German universities. I wonder if the speaker from Hamburg, the Federal President, has ever heard that before? The liberal German university system has been reversed in the last decades.

#### **Correction, Mr. President? - Nothing.**

The former General of the German Federal Armed Forces, Mr. Schultze-Rhonhof, recently pointed out that in judgments passed in Nuremberg after the end of the war, a certain history of victories with binding effect has been laid down until today. Is that the reason why German historians seem to be glad that the usual British guildsmen have gladly taken on the role of continuing victor's history?

#### **Is this what freedom of research and teaching looks like?**

On the day when the Federal President spoke in Hamburg, top representatives from business and trade unions joined in a duet with excessive investment demands on the German tax payer. The money should only bubble over in the coming years. Can't you gentlemen remember that in the days of the "social market economy", German companies pursued a research and development policy that was designed to last for decades?

This could be denied from what one had earned oneself before the American system of "shareholder value" catapulted the social market economy to the moon. The current German President was there with his nose as Secretary of State at Schröder's Agenda 2010, when the exit from the social market economy was completed. Two examples from the state structure almost suffice to describe the German dilemma of the targeted transformation of our state, which misses the citizen.

For the Federal President, however, it comes even thicker, because the country still has a certain time before his eyes in which mutations of "Lower Saxony land law" did not prevail here. If the Federal President had read the *Süddeutsche Zeitung* days before, he would inevitably have noticed a comment by Professor Heribert Prantl, a former public prosecutor. In it Professor Prantl certifies the Federal Minister of Defense AKK from Saarland clearly and unequivocally that her global army land dispatches cannot be made with the Basic Law.

#### **Where is the word of the Federal President?**

This doubt about the state's lawful actions cannot be allowed to pass without having to put up with huge distortions on the former sovereign. A few years ago, the former German Chancellor Gerhard Schröder pointed out in all seriousness that with his Ent-

The applicant submits that the decision to initiate the war against Yugoslavia violated the Charter of the United Nations. And against the German constitution and the penal code one would rather not look into that.

What should the soldiers of the Bundeswehr think when they remember the closest colleague of the then Chancellor and now Federal President? Our constitution and the role of Germany are not only being criticised by so-called "Reich citizens". In the vernacular it is said that something is "taken from underneath someone's butt" when powerlessness plays a role and something bad cannot be prevented.

In our state, high representatives appeal to civic-mindedness, if it was they who presented the citizen with a fait accompli, decades after the lessons that should have been learned from the "Nuremberg Trials". From the past, only those lessons are accepted which fit the rulers and their clients in NATO or the EU into the current context. It is not only Germany's participation in wars contrary to international law that concerns people, to put Professor Prantl's commentary in context. One of the world's most respected German experts in constitutional law is the former German Minister of Defense, Professor Rupert Scholz. On the Chancellor's migration decision of September 2015 and the developments since then, he was clearly heard in the press weeks ago.

According to press reports, he spoke in this context of "continuing constitutional breach". What more can one say in a country, unless one deliberately goes out to inject the German people with impotence? Where then is the public word of the Federal President and the emphatic influence on the Federal Government to counter the public word of Professor Rupert Scholz with the German constitutional reality, where there is no doubt that state action on such a scale is lawful?

The Federal President could lament in Hamburg about "political correctness" as he wanted. For years and days the well-founded impression has prevailed in Germany that the press, as the "assault gun of democracy", has only the task of securing the aforementioned and by-passing the legislator-driven restructuring of our state by means of key functions. This is in clear association with parties that have been in a process of "self-development" for more than ten years.

This is not only noticeable to citizens, it gets on their nerves.

## **Sahra Wagenknecht most popular politician in Germany according to survey**

Sahra Wagenknecht, former leader of the Left Party, is for the first time the most popular female politician in Germany, according to a survey. Wagenknecht's positions regularly cause a stir within her own party. However, she is apparently meeting with approval from the voters.

A recent survey by the opinion research institute INSA sees left-wing politician Sahra Wagenknecht at the top of the politicians' ranking for the first time. In the survey, which INSA conducted for the Burda magazine Focus, Wagenknecht was able to increase her score by seven points compared to the previous week and achieved an approval rating of 114 points. Chancellor Angela Merkel thus slipped to second place with 111 points, although she too was able to gain one point. The INSA rankings show Green party leader Robert Habeck in third place with 110 points (up three). Former Union faction leader Friedrich Merz followed in fourth place with 102 points (minus three). Merz is thus the most popular politician of the Union after Merkel. Behind him, Federal Health Minister Jens Spahn is in sixth place with 100 points, the CSU chairman and Bavarian Minister President Markus Söder is in seventh place with 98 points, and the Minister President of North Rhine-Westphalia Armin Laschet is in tenth place with 96 points.

### **Coming under pressure within the party: Left-wing chairmen Bernd Riexinger and Katja Kipping in Berlin on Monday**

Annegret Kramp-Karrenbauer, the current CDU chairwoman and Federal Minister of Defense, is only 18th in the ranking, which includes 22 top politicians, with 72 points. Before the CDU party conference next weekend, her position within her own party is considered to be ailing.



More on the subject - Saxon Left votes for "Peace with Russia" as a focus of political work

Sahra Wagenknecht, the leader of the current ranking, retired from her position as leader of the left-wing parliamentary group on 12 November 2019. With her emphasis on the social question and her pragmatic stance on migration, she was at odds with the leadership of her party. After the Left's defeat in the state elections in September, she accused her party of neglecting social problems and increasingly being perceived as a "green-liberal lifestyle party". A few days ago she wrote on Facebook:

I think the political debate suffers from the fact that people think too much from the big city, because most journalists and many politicians come from this milieu. From the completely renovated old building in Berlin-Mitte, one can confidently condemn the car or the oil heating. In rural areas or even in the small town life looks different. There are hardly any industrial jobs in Berlin, but in many places these are the only ones that still allow for a good standard of living.

INSA surveyed a total of 2036 eligible voters between 15 and 18 November 2019. They were asked the following question: "Which politician best represents your interests?" The scale ranges from zero to 300 points.

## Development aid increases the causes of migration

"Charity does not eradicate the roots of poverty."

It is clear to those in the know that the mass migration of young Africans without prospects can only be prevented if they can find education, meaningful work and a decent income in their home country. That is why many are calling for an increase in development aid. But as a rule, development funds have not improved the lot of the poor masses so far, but have worsened it. The money has always largely trickled away in the private pockets of corrupt elites who have no interest in improving the living conditions of the poor population. Development aid stabilises the balance of power and increases the causes of migration.

In an impressive book, Volker Seitz, who has worked as a German ambassador in African countries for a total of 17 years, has relentlessly pointed out the plight of official development assistance. In the introduction he writes: "My experiences and lessons learned have led to my assessment of Africa's development opportunities and the often unfortunate role of development aid. Development aid is given in abundance and is not questioned as a good deed for the poor. On the contrary, in a survey 71% said ... they were in favour of doubling development aid. When you're on the ground, you see things differently after a short time." (S. 27)

The money is paid to mostly corrupt governments whose will it is largely up to them what they do with it. Most of the money disappears into their private pockets. And projects that are set in motion often sort of dry up over time. The poor get nothing. The central problems in education and health care, as well as in the promotion of entrepreneurial initiatives from within the own population, are not addressed. "Development aid as we know it today invites abuse. I have encountered corruption as a private gain at the expense of the common good in all developing countries." "The Samaritan behaviour of the North weakens or destroys the incentives of the recipients to make their own efforts. Our pity only reinforces a social welfare mentality that is already chronic in some African countries. (S. 100, 101)

### **Less development aid**

And Volker Seitz comes to the radical demand: "The highest goal must no longer be an increase in development aid that paralyses the forces of self-help, but as little money as possible, only as much as is urgently needed. I have no doubt that development can only take place through the active and convinced participation and initiative of each individual.

He sees his assessment shared by many Africans. He quotes the Ugandan journalist Andrew Mwenda, who has often been in prison for criticising the government: "Of course aid workers may achieve humanitarian success here and there by saving a starving village and providing acidic drinking water elsewhere, but at the same time they destroy the most important mechanism that could eradicate poverty in the long term. Aid undermines the development of a competent, incorruptible state apparatus that serves the interests of the population. (S. 28)

James Shikwati, founder of an economic development agency in Kenya, who writes in Spiegel and FAZ, among others, also massively criticizes the classic policy of development aid: "In the industrialized countries the impression is always created that without development aid Africa would perish. ... Unfortunately the devastating European urge to do good can sometimes not be met with reason. ... If development aid is stopped the political elites would be the first victims because their power structures would be broken. The question of an independent African solution would then be on the table. ... Cessation of aid will reveal that most international agencies have used the African plight to collect donations to give themselves a humanitarian slant.

- The illusory do-gooderism is therefore still to be seen in a much broader sense.

Volker Seitz draws a first conclusion of the development aid so far right at the beginning. Apart from a few exceptions, development funds have neither ensured more growth in the long term nor raised the standard of living, nor improved the lot of the poor, but rather worsened it. The gap between the super-rich and the beggars is getting wider and wider. The authoritarian state apparatus does not care that there is a lack of drinking water, power cuts are the order of the day and hygienic conditions are responsible for the high infant mortality rate. They have taken care of themselves. Even if development funds had to be spent for a specific purpose, they would still find their way into the wrong coffers.

When foreigners build hospitals, schools and roads, the government does not have to do it and can spend the money on luxury goods instead. The African elites are world champions at drinking champagne, he said, and their motorcade parades are characterized by an astonishing Mercedes-Benz density. People would like to call this type of leaders "from the Wa Benzi tribe". "Most of the leaders have luxury villas in numerous countries. There are heads of state who spend the annual salary of a European head of government on themselves and their entourage in New York in a week. If the media do make such accusations, they think they can refute them with the killer argument 'This is racism'. (S. 29)

If you take an honest stock of the situation, Volker Seitz writes that the bulk of the aid has evaporated under the African sun. In the absence of good governance, i.e. a lack of transparency, accountability, efficiency, democratic participation in decision-making and, above all, the rule of law, "even after almost 60 years of independence, most African countries have still not tackled the fight against poverty and corruption and overcoming their impasse. There is still incredible poverty and need. At the same time, the wealth of the upper class often takes on fairytale dimensions. We, as observers, are faced with an expensive pile of shards, but no one has to justify how little the high expenditure ultimately brings in." (S. 30)

### **Migration does not concern the elites**

Seitz diagnoses that the African elites do not care if tens of thousands of their citizens emigrate in an uncontrolled and chaotic manner and turn to other countries where they hope to find a better life than at home. If they were responsible governments, they would have to urge their compatriots to stay in the country and give them the prospect of a better life. But nothing of the sort would happen. On the contrary, some African governments are demanding a right to migration. –

If I remember correctly, no African state voted against the UN migration pact, which postulates a right to migration and unhindered migration routes open everywhere. –

For the African authoritarian regimes, emigration is obviously not an alarm signal, but a valve. "They get rid of the discontented young citizens who already populate the African centres in large numbers and have no chance of finding a job there. With the export of unemployment, the urgency of their own development efforts diminishes." (S. 30)

"The refugee tragedies of Lampedusa are a reminder that African dictators are indifferent to the plight of their own people. Not a word on the official website of the African Union. But this is understandable, because <for nothing Africa would have to ask itself painful questions about its societies and leaders>." ('Business Day', Johannesburg)

The migrants would know how dangerous the crossing is. In many families, clans there is someone who has tried to find his luck in Europe by boat, which is mostly only possible because family members, the clan, the village, join together to finance the crossing. "So people know what they're getting into. Those who do not succeed have the stigma of being among those who did not make it. Because they should work there and send money. The African-Canadian continent is the only region of the world where the absolute number of poor continues to rise. If you look at the population development, if you take into account economic and political facts, then it should be clear to everyone that people will continue to come in the future." (S. 139)

In addition, many of the education-hungry and training-willing young people who are looking for their life chances do not find any possibilities for this in their home countries and therefore leave them and often do not return after the qualification phase abroad. "African governments have no interest in them. Apparently, the ability to learn, dynamism and innovation are not always desired, especially when corrupt elites want to protect their assets from the new and from competition in their own country. African students have great problems to get by in their home countries and try to find employment in Europe or the USA".

Africa too thousands of university teachers, doctors, engineers and intellectuals every year because they are prevented from developing their careers in their home countries and because Europe and the USA offer them better working conditions and lucrative jobs. "In less than two decades, Africa has lost a third of its scientists. Some 20,000 doctors and nurses alone leave sub-Saharan Africa every year. ... The lack of qualified scientists, for example at African universities or in companies, is becoming increasingly serious. ... It is unacceptable that there are more doctors and nurses from Ghana working in the British Isles than in Ghana itself. (S. 137, 138)

The loss of scientists, engineers, doctors (one in four African doctors works abroad) has devastating consequences for the economy and the education and health systems, which must be the starting point for overcoming poverty and misery. "Although the emigrants send a lot of money home. A company like Western Union, which specialises in this type of transfer, has been booming for several years. But this is the opposite of development aid. For development to take place under their own steam, it is absolutely essential that the well-educated want to live at home. (...) It would make sense to limit the influx of skilled workers from developing countries and instead ensure that they can work in their home countries.

#### **The central problem: the local corrupt power elites**

German development aid for Africa is organised from state to state and always starts, writes Volker Seitz, from the two premises that we must not interfere in the sovereignty of poor countries and that their elites themselves are interested in improving the lives of their citizens. But this does not work and has nothing to do with reality. The aid flows into government structures that are not geared towards growth and the future, but solely towards maintaining power and self-enrichment of the potentates. Nothing is developed with development aid, but the political power relations over the peoples who remain poor are cemented with their help. Ultimately, the elites have no interest whatsoever in overcoming the poverty of the population, since the flow of development funds would then dry up in their pockets.

"In countries where I worked, donors (states) often paid a 'motivation premium' to get the officials responsible to do their job. In all the states I know of, there is a finely balanced system of mutual benefit."

The "poison of good gifts" has the opposite effect of development, because governments are not committed to respecting agreements. "Even with regimes that have been in power for two or three decades, we still hope for the good in people. Political power that is not subject to control always degenerates: neither economic nor social development can be imported. Anyone who still advocates this after more than five decades of development aid is naive at best. (S. 41)

A former French ambassador to Togo told Volker Seitz that at the time when donor countries had stopped aid to Togo, corruption in the country had fallen considerably. For there was nothing worth mentioning to distribute and the regime had suddenly had to take care that the few funds were not misappropriated on a large scale.

"Tanzania, like no other country, proves the failure of development aid. The country has all the resources it needs to be happy and none of the excuses that are normally used as an excuse for why things didn't work out after all. (There was) no war of independence, no despotic

Sole rulers, no military dictatorship, no coup d'état, no tribalism (tribal conflicts), no religious conflicts, access to the sea, no drought or flood disasters, no exuberant crime, no harmful oil or copper wealth, but enough diverse raw materials.

Despite this good starting position and the fact that Tanzania has been the donors' darling since independence, it remains one of the ten poorest countries in the world". (S. 42, 43)

Since independence, the states of Africa have been ruled by oligarchies that share the country's wealth undisturbed among themselves. "The bosses are mainly concerned with the details of protocol. The rituals surrounding presidents are reminiscent of courts in feudal times. The courtiers (recruited from their own clans and clans) don't think about the future of the country, but put all their energy into chafing at the boss, acquiring titles and taking over cabinet posts that do little work but offer many opportunities to get hold of state money. The Autocrat does not govern, but rules in a pre-democratic, chiefly style. (S. 89, 90)

In Congo and Cameroon the government has 65 ministers each, in Uganda 70, in Ghana 75 and 94 ministers enjoy the favour of the president in Kenya. "The president of Kenya expects development aid and at the same time approves an annual salary of 427 900 US dollars. In Nigeria, a senator even receives 1 million dollars annually. Libreville, the capital of Gabon, can afford a mayor who receives around 30,500 euros a month (in comparison: his colleague in Berlin earns 12,500 euros), while many of the 700,000 inhabitants have to make do without running water, sewage disposal and a regular electricity supply. (S. 98)

In official development assistance, the "ownership principle" (personal responsibility) is at the forefront and is preferred at the expense of project-oriented assistance. "But if you want to make people in Africa laugh, you only have to talk about African ownership. Yes, yes, ownership already exists, but it is primarily 'private' and less 'African'. We should no longer overhear the laughter of the poor in Africa. Everyone knows that the bosses have dozens of finest properties in Europe, Cana-da, USA, Hong Kong and even Brazil. In the most expensive district of Paris, Avenue Foch is also known in African vernacular as the Avenue des dictateurs.

"In London, too, luxury real estate is particularly popular among rich Africans from Nigeria, Ghana, Gabon, Cameroon, Senegal and the Democratic Republic of Congo in the traditional districts of Westminster, Kensington and Chelsea. According to real estate agent Engel & Völkers, a penthouse apartment in Hyde Park was sold to an unnamed African for around 162 million euros in autumn 2014. (S. 96)

"Dignitaries in Nigeria are said to have embezzled the unimaginable sum of almost 500 billion US dollars since independence (1960). In two cases, corruption investigators are claiming back 139 and 584 billion US dollars from former presidents, who are not mentioned by name. Nevertheless, American economists, Western politicians and the UN are of the opinion that Africa needs more money. Volker Seitz is left with only irony:

"The International Conference 'Solidarity and Globalisation: innovative sources of financing for development and against pandemics' in Paris in spring 2006 was a good opportunity for the then French President Jacques Chirac, former UN Secretary General Kofi Anan and the then President of the African Union, Denis Sasso Nguesso, to call for new resources for the poor in Africa. Nguesso had, as it became known, just spent 280 000 dollars for a week in a hotel in New York. An easy task for a president (of the People's Republic of Congo) who, as French media reported in February 2009, needs 18 properties and 112 bank accounts in France. The UN is demanding 50 billion dollars to fight poverty and calls for 'innovative financing instruments'. One source of money should be the introduction of a separate flight tax. Since the surcharge is to be levied in favour of the poorest, there will certainly be a great deal of popular support." (S. 77)

At the beginning of October 2019, an employee in the Paris police prefecture killed four police officers with a knife and fatally injured another gendarme before he was shot dead by a police student (the training is apparently working). Politicians were immediately on the scene, describing the perpetrator as mentally exhausted and trying to position the crime somewhere between professional overload, stress at work and burnout. The French Minister of the Interior said that nothing indicated a threat and the perpetrator had not shown any behavioural abnormalities. In this terrible case, politicians have made a desperate effort to conceal the suspicion of terrorism.

But the shot backfired properly. The perpetrator had converted to Islam and had radicalized himself in dubious backyard mosques and via Islamist networks, which did not go unnoticed by his colleagues. The perpetrator worked as an administrative employee in the intelligence department of the Paris police, which is also responsible for the fight against extremism. His colleagues reported their findings to their superiors - but nothing happened, probably because they were afraid of Islamophobic accusations. At the funeral service for the killed police officers, French President Macron mimed the great statesman, announced an unyielding fight against Islamic terrorism and called on society to be vigilant. Such words are sometimes the reason why politicians are at the bottom of the professional rankings.

Speech by Chancellor Angela Merkel in the German Bundestag on 27 November 2019

This week the general debate on the 2020 budget will take place in the German Bundestag. Traditionally, the government uses this to praise its own work highly. This time, however, the opposition was particularly belligerent: AfD, FDP and LEFT fired sharp shots in the direction of the Chancellor. Merkel herself seemed aimless.

General debates in the Bundestag offer a particularly good opportunity for the members of parliament to raise their profile. The game is always the same: government politicians defend their program, the opposition tears it apart, even in heated debates. For example in 2003, when the then CDU opposition leader Angela Merkel aggressively attacked SPD Chancellor Gerhard Schröder.

ted, people disliked above all his permanent grin on the government bench. Or in 2010, when SPD-Chief Sigmar Gabriel explained to the black-yellow federal government "It is not an intellectual challenge to comment on your government policy. You underchallenge us. How could it happen that a government is as run-down as yours?" In the current legislative period the tone has changed, it has become darker and sharper. This is also due to the AfD Group, which is using its attacks to meet the Chancellor and the GroKo politicians in a very personal way. This Wednesday is no exception.

#### **A clear conscience...**

Even before the Chancellor, the largest opposition party in the Bundestag had the right to speak. In this case, it was AfD faction and party leader Alexander Gauland who first stepped up to the lectern. His main topic was that the German government had decided from Germany to save the climate and in return put the country's energy supply at risk. Gauland explained that the German energy turnaround had failed and that energy supply security was no longer guaranteed:

"Perhaps the federal government is of the opinion that people will warm to their good conscience in the future. But the topic is so charged with substitute religion that the question of right or wrong no longer plays a role. It is completely buried under the criteria of good and evil."

Where terms like "climate deniers" were circulating, reason had taken its leave, continued Gauland. Even if Germany were to cease to exist tomorrow, the effects on world temperature would be practically undetectable, the head of the AfD is certain. Instead, the Merkel government is ruining the automotive and mechanical engineering industries for its energy turnaround:

"The Merkel years will be remembered as a leaden time in which public debate was stifled in the being of hypermorality."

Gauland also identified the population explosion in Africa as the biggest problem for the planet. Politics must be based on realities and not on pious hopes. Gauland explained that the federal government would rather abolish Germany as a business location than let the words "birth control in Africa" slip through its lips.

#### **Merkel thanks USA...**

Unperturbed by the previous speaker, the Chancellor did not even respond to the accusations of the AfD. She began at the microphone of the Bundestag, referring to NATO's 70th birthday this year. She said that the Alliance had ensured, especially during the Cold War, that there had been no conventional war in Europe. Merkel said that the USA in particular was to be thanked for this. By the beginning of the coming 1930s, Germany would therefore also achieve the promised two percent target for military spending:

"More than during the Cold War, the preservation of NATO today is in our very own interest. Europe cannot defend themselves alone at this time, we are dependent on this transatlantic alliance. And therefore it is also right that we work for this alliance and take on more responsibility."

In the further course of her speech, the Chancellor commented on what she saw as a hybrid threat of NATO by Russia, the economic challenges facing China and the protests in Hong Kong, who would have to find peaceful solutions.

It was only then that Merkel slowly began to talk about domestic political issues. She praised the balanced budget and the actions of the Grand Coalition so far. As a side blow to the AfD, the head of government finally commented on freedom of opinion:

"Freedom of speech is given in our country. And all those who constantly claim that they can no longer speak their mind, I simply have to say to them: If you speak your mind, you have to live with the fact that there is contradiction. There is no such thing as freedom of opinion for free. Freedom of speech knows borders, and they begin where the agitation begins, where hatred is spread."

For the dignity of man is inviolable. Against all those who violate this fundamental right, one must stand up. The Chancellor ended her speech with an appeal to her own ranks that there was still much to be done and that the governing coalition should therefore continue to work together for the entire legislative period - she was happy to be part of it. This is a clear recommendation to the SPD, which will discuss the exit from the GroKo at its party conference in just over a week's time.

#### **Federal government sleepwalking...**

Afterwards, FDP leader Christian Lindner had few warm words for the work of the federal government. He accused the Grand Coalition of failing in economic policy. He said that the economy was only growing by 0.1 percent - far too little compared to the rest of Europe. Merkel had also made far too little reference to this in her speech:

"There is no longer any growth momentum here. You spent just under four and a half minutes on the economic situation in the narrower sense, Chancellor. I can only say: If you leave the economy on the left, you shouldn't be surprised about problems from the right."

According to Lindner, the Federal Government is concentrating far too much on the expansion of electric mobility. At the same time, jobs are being lost in the automotive industry. At the same time, the CDU had emphasized the importance of the non-fossil fuel combustion engine at its last party conference:

"I like the CDU better than this federal government. This government is sleepwalking towards an impending economic crisis, sleepwalking towards an economic crash.

In the opinion of the FDP chairman, the federal government must also pick up speed in digital policy if it wants to be up to date.

### **A gaping wound.**

Even Dietmar Bartsch, the leader of the parliamentary group of the party Die LINKE, did not leave a good hair on the head of the governing coalition. He saw a contradiction in the fact that the Chancellor praised the GroKo in high tones, but CDU member Friedrich Merz had recently spoken of a "grotesquely bad" appearance of the federal government:

"It's not the appearance that's bad, it's unfortunately your politics are often lousy. Only 26 percent of the citizens still see the work of the federal government as a strength of the country. In view of the multiple self-employment you pursue and your mid-term review, this is even a rather high figure."

Bartsch especially criticized the announced income check for the planned basic pension. This would be so hard that two million pensioners would lose their claim, although they could well use the support:

"This is reality. You put a much too small band-aid on a gaping wound. Next year's budget has three characteristics: it is powerless, it is inactive, and it is irresponsible."

It was remarkable that employers and unions alike had called on the federal government to finally provide more money for investments in the future.

### **German arms exports: Merkel for more arms deliveries to Africa**

The members of the German Bundestag will continue to argue about next year's expenditures all week, and on Friday the federal budget for 2020 is to be passed. One thing is already clear: the opposition will certainly not be satisfied with this - perhaps not even all the governing parties.

The lies about Assange must stop now

Newspapers and other media in the United States and the United Kingdom have recently publicly professed a passion for freedom of expression, particularly their right to publish freely. They are concerned about the "Assange effect".

It seems that the struggle of people who speak the truth, such as Julian Assange and Chelsea Manning, is now a warning to them: that the gangsters who dragged Assange out of the Ecuadorian embassy in April could one day come to get her too.

The Guardian repeated a common refrain last week. The extradition of Assange, the Guardian said, "is not a question of how wise Mr Assange is, much less how likeable he is. It is not a question of his character, nor of his judgment. Rather, it is a question of the freedom of the press and the public's right to know."

So the Guardian tries to separate Assange and his groundbreaking achievements. The latter have benefited the British daily, but they have also exposed their own weakness, as well as their tendency to curry favour with the predatory powers and to throw dirt on those who bring their double standards to light.

The poison that drives the persecution of Julian Assange is not as easy to identify in this editorial as usual; it does not contain any fairy tales about Assange who allegedly smears embassy walls with excrement or treats his cat badly.

Instead, the insidious references to "character" and "judgment" and "sympathy" continue a smear campaign that has now lasted for almost a decade. Nils Melzer, the UN Special Rapporteur on Torture, used a more appropriate description. "A relentless and unrestrained campaign of public harassment is underway," he wrote. He defines bullying as "a constant stream of degrading, humiliating and threatening statements in the press." This "collective mockery" acts like torture and could lead to Assange's death.

Since I can testify to much of what Melzer describes myself, I can vouch for the fact that his words are true. If Julian Assange should break under the cruelties that have been and will be inflicted on him week after week, month after month, year after year - as doctors warn - newspapers like the Guardian are partly responsible for this.

A few days ago, the London correspondent of the Sydney Morning Herald, Nick Miller, wrote a sloppy, sleazy article entitled "Assange has not been rehabilitated, he just sat out justice." He referred to the fact that Sweden has dropped the so-called Assange investigations.

Miller's report is not untypical of his omissions and distortions, while at the same time posing as a tribune for women's rights. Independent work, real research: no chance. The report is a single slander.

It contains nothing about the documented behaviour of a number of Swedish zealots who have hijacked the "accusations" of sexual misconduct against Assange and made a mockery of Swedish law and the decency vaunted by this society.

He fails to mention that in 2013 the Swedish prosecutor tried to drop the case and sent an e-mail to the Crown Prosecution Service in London saying that she would no longer maintain the European arrest warrant. The reply to this e-mail was: "Don't you dare!!!" (Thanks to Ste-fania Maurizini from La Republicca)

Other mails show how the Crown Prosecution Service advised the Swedes not to come to London to question Assange - which would have been standard practice - and thus prevented movement in the matter, which could have led to Assange's release in 2011.

There was never an indictment. Nor were there any charges. There has never been a serious attempt to confront Assange with "charges" and to question him about them - an action which the Swedish Court of Appeal declared negligent and which the Secretary General of the Swedish Bar Association has since condemned.

The two women involved said there had been no rape. The crucial written evidence from their SMS messages was deliberately withheld from Assange's lawyers, obviously because it undermined the "allegations".

One of the women was so shocked by the arrest of Assange that she accused the police of taking her by surprise and changing her testimony. Attorney General Eva Finne rejected the "suspicion of any crime".

The Sydney Morning Herald staffer embezzled how an ambitious and compromised politician, Claes Borgstrom, has emerged from the liberal façade of Swedish politics and taken up the case again and breathed new life into it.

Borgstrom hired a former political comrade-in-arms, Marianne Ny, as the new public prosecutor. Ny refused to guarantee that Assange would not be sent to the United States if he was extradited to Sweden. The Independent reported that "according to diplomatic sources..."

US and Swedish officials have already informally discussed the possibility of placing Julian Assange in US custody. That was an open secret in Stockholm. That freedom-loving Sweden had a documented sinister tradition of extraditing people from the CIA was nothing new.

The silence was broken in 2016 when the United Nations Working Group on Arbitrary Detention - a body that decides whether governments comply with their human rights obligations - stated that Julian Assange was being held illegally by Britain and called on the British government to release him.

Both the British and Swedish governments had participated in the UN investigation and promised to abide by its decision, which was made with the weight of international law. But British Foreign Secretary Philip Hammond stood up in Parliament and berated the UN committee.

The Swedish case was a fraud from the moment the police secretly and illegally contacted a Stockholm tabloid, setting off the hysteria that was to destroy Assange. The Wikileaks revelations of US war crimes had embarrassed the power's henchmen and their self-interests, who call themselves journalists; and the unsociable Assange would never be forgiven for that.

The hunting season was open. Assange's torturers in the media copied each other's lies and insults. "He really is the most disgusting fucker," wrote Guardian columnist Suzanne Moo-re. It was common knowledge that he had been accused, which was never the case. In all my life of reporting on places of extreme turmoil, suffering and crime, I have never seen anything like this.

In Assange's home country, Australia, this "bullying" reached a climax. The Australian government was so eager to extradite its citizen to the United States that in 2013 then Prime Minister Julia Gillard wanted to withdraw his passport and accuse him of a crime - until she was told that Assange had not committed a crime and she had no right to withdraw his citizenship.

According to the website Honest History, Julia Gillard holds the record for the most submissive speech ever given to the US Congress. Australia, she said with applause, was America's "great buddy". The great buddy conspired with America to hunt down an Australian whose crime was journalism. He was denied the right to protection and proper assistance.

When Assange's lawyer Gareth Peirce and I met two Australian consular officers in London, we were shocked that what they knew about this case was limited to "what we read in the papers".

That Australia let him hang is the main reason why Ecuador granted political asylum to Julian Assange. As an Australian, I found this particularly shameful.

When he was recently interviewed about Assange, the current Australian Prime Minister Scott Morrison said, "He should foot the bill." This rowdy approach, with no respect for truth and rights and principles of law, is why the largely Murdoch-controlled press in Australia is now worried about its own future, as are the Guardian and the New York Times. Their concern has a name: "The Assange precedent."

They know that what happens to Assange can happen to them. The basic rights and justice that are denied to him can also be denied to them. You have been warned. We have all been warned.

Whenever I visit Julian in the gloomy, surreal Belmarsh prison world, it reminds me of the responsibility that we who defend him bear. Universal principles are at stake in this case. He himself likes to say: "This is not about me. It's about much more than that."

But at the heart of this remarkable struggle - and that is what it is above all: a struggle - is a

Man whose character, I repeat: character, has shown the most amazing courage. I bow my head before him.



Today a message from Annegret Kramp-Karrenbauer, still CDU chairwoman, fluttered into my mailbox.

Immediately after the salutation the following paragraph was found:

The initiative of the JU, presented by Tilman Kuban, to answer the Chancellor's question by means of a primary election, was rejected by the majority of delegates. Grassroots initiatives are not welcome in the former People's Party.

None of the really burning problems, such as the destruction of the car industry, the educational misery, migrant crime, the continuing unchecked immigration without (or with) forged papers, the radical left-wing terror in Leipzig and elsewhere, the lost state elections, the loss of members, the endangerment of our savings deposits by negative interest rates and European deposit insurance, to name but a few, were dealt with. Instead, it was whitewashing as at an SED party conference.

Prime Minister Bouffier was enthusiastic that Germany had become a "country of longing" for the world, and that this was a success of the CDU's policies. Of course, when the social benefits for migrants are often higher than the wages that can be earned in the countries of origin, it is no wonder that these social benefits have become the number one cause of flight. And yes, this is a result of the Chancellor's party's erratic "refugee policy", but one that will lead to Germany's ruin if it is not stopped soon. It is not the migrants who are to blame for the disaster, who gratefully accept the generous offer made to them by politics with the help of the plundering of the social systems, but the reality refugees (Boris Reitschuster) à la Bouffier, Merkel, AKK e tutti quanti.

Friedrich Merz was allowed to give a brilliant speech against Greta, in order to mislead the members and voters to the erroneous assumption that the party leadership or even the chancellor could turn against the hysteria caused by Greta and return to a rational climate policy. What is really planned was put on record by Merkel disciple Daniel Günther, Minister President of Schleswig-Holstein, after the end of the party conference: "With reasonable people in the Green Party, it is possible to govern well together - we are proving this in the federal states". Aha, the CDU sees in the Greta disciples the rescue anchor to stay in power. Against this background, the Merz speech must be seen as plain deception. AKK's claim to "spiritual leadership" is more than questionable.

If the trend in Thuringia continues, and the CDU party conference has done much to ensure that it does, Black-Green will at most be enough for a minority government after the federal elections. Then the next anchor of salvation could be the party that Thuringia is trying to position as a CDU coalition partner. If black, dark red and green are not enough either, the SPD can be accepted if they get over the 5% hurdle. That would then be a political junk shop. There is also no longer any hope of the CSU as a saviour in times of need. Anyone who, like Prime Minister Söder, has no idea how to deal with the AfD, and therefore lapses into the idea of claiming that the AfD wants to go back to the 1930s, invites you to stop taking him seriously. But when Söder comes to the conclusion that "there is no real difference between Höcke and Hitler", one finally asks oneself whether this man still has all the cups in the cupboard. Such an outrageous trivialization of the greatest criminal in German history has so far only occurred in the Antifa. It has nothing to do with politics anymore, only if one wants to be polite, with headless panic. Söder will not fight the AfD with Nazi comparisons, but he will scare away all voters who still have their wits about them.

No, the CDU is certainly not a workshop for the future, not even a repair shop, but a disoriented, disintegrating bunch. The Union of Values must ask itself whether it really wants to scoop water out of the sinking Titanic with a spoon, or build a rescue island from the fragments. Germany urgently needs a party of the middle class. The CDU no longer wants to be that party. It's high time to fill the vacuum.

**Billy** With your permission, I would like to ask you what you personally think of the German political parties and the government, whereby I am thinking especially of the CDU party and the Chancellor Merkel, the would-be Chancellor and CDU chairperson AKK and Annegret Kramp-Karrenbauer, who also makes herself important as <Minister of War>. Julia Klöckner, who is acting as Federal Minister for Food and Agriculture, and Ursula von der Leyen, who is the new President of the EU Commission, also fall into my question.

**Ptaah** We have already talked about these things briefly and superficially several times, but if you now ask me for my personal opinion, then I want to comment on it and say that I, as an observer of the whole thing, cannot give a good judgement with regard to the party CDU and the various persons mentioned by you, nor for the majority of the other persons belonging to this party.

Beginning with the CDU party you mentioned, I have for years, under the power of Chancellor Mer-kele, noticed anti-grass roots manipulations which are completely contrary to correct governance, popular solidarity and world peace, and which therefore have a destructive, dulling and inciting effect on the people in every important respect. This has been expressed in a disastrous way by the Chancellor's irrational stupidity and the sectarian and matriarchal attitude of her culture of welcome to refugees, as a result of which a great many people have died and will continue to die while fleeing, for which she must be held severely accountable. Below are some Twitter posts with answers from former military personnel and their families, which impressively present what they experienced and the aftermath.

"It made me realize that we are cogs, I am a war machine, and when **we are no longer useful, we are thrown away**. We use these false beliefs and [this false] ethics to make us feel like we're important, and for financial stability we keep going. It has broken and destroyed who I was."

"**Shall I answer for the dead? You can't type anymore**. My husband was released because of his post-traumatic stress disorder (PTSD), then he got cancer from 'Agent Orange' and died. My cousin died of chemical-induced cancer, my other cousin is currently in treatment for the same thing and also has PTSD.

"I spend sleepless nights feeling guilty because none of the horror and suffering I have seen is important; **because we are all just grist to a mill of pain, run by madmen** because when I speak and say, 'Endless war is wrong', my comrades who are are haunted by their own demons."

"As a mother, I was proud of my son when he signed up to serve his country in his last year of school. He served in three missions in Iraq. **This young man, who had his whole life ahead of him, is now <spiritually> (consciously) and emotionally broken beyond recognition, and the army is not helping.** "

"The 'Agent Orange' that my grandfather was exposed to in Vietnam caused his cancer and his death, and possibly various diseases and disorders that my mother my aunt, my siblings and I have. **The army and the government knew the dangers <Agent Orange> when they started using it.** "

My brother is now constantly drunk, his alcohol addiction arose from his inability to cope with PTSD. **He served in Afghanistan and had to kill children just to come home to me, his little sister, and cry in my lap. I was eight.** "

"My best friend joined the army right out of high school because his family was poor and he wanted a college education. He did his time and then served even longer. Just when he was ready to retire, he was sent to Iraq. **You sent him back in a box. It destroyed his children.** "

The high number of suicides committed by US veterans also clearly shows the lack of good offers of help. It is assumed that 20 veterans take their own lives every day - which amounts to 18 percent of all suicides per year. It seems that the US Army is "surprised" that so many shocking answers to their question have been received. With a certain degree of understanding of human nature, it should be easy to understand why the people concerned are in the condition they are in. ## Constantly new proposals to save the Framework Agreement

For years now, and even now, new ideas and fantasies have been put forward as to how the Framework Agreement could be saved. The latest proposals show in an exemplary way that reality and fantasy are far apart. For the EU-No committee it is clear that the exercise Framework Agreement must be broken off and does not require a "rescue". The sale of Switzerland must be rejected unconditionally.

It is characteristic of the long-standing discussion on the Framework Agreement that new ways of saving the Framework Agreement are always being sought. New names for the Framework Agreement have been invented again and again in order to conceal the creeping accession to the EU. At first, the Federal Council said that it was a matter of institutional integration. Soon, only institutional issues were mentioned, because integration might sound somewhat binding and convenient. Later the name cooperation agreement was brought into play. Or even a new edition of the framework agreement was popularised as "Bilateral III". But these are all just diversionary tactics and deceptions. To crown this policy of cover-up, Mr Juncker even wanted to praise the subjugation treaty as a friendship agreement. But this shot probably backfired.

The latest coup: a so-called "interim agreement" is to save the framework agreement with the EU. Academics are taking a fresh approach to this game of words. As if Switzerland's subjugation to the EU, i.e. its actual accession to the EU, needed a "rescue". But there is something interesting about this proposal. According to the proposal, there is still a need for negotiations in the following area:

- › Exceptions to the dynamic adoption of law in vital areas (wage protection, State aid, the Citizens' Directive)
- › Fair dispute settlement procedure with a genuine arbitration tribunal
- › No guillotine - and certainly not an extended guillotine

With this analysis, the scientists indirectly come to the core problems of the agreement. These are the automatic transfer of rights, the foreign judges and the new penal and guillotine measures. These are the areas that undermine and destroy our democracy and the Swiss success model. These are the problems that go to the heart of the agreement. What is also clear is that the EU will not go a millimetre further in these very areas. After all, its main concern was that Switzerland should be institutionally integrated into the EU structures. Otherwise there would obviously be no need for a framework agreement. So these academic fantasies have nothing to do with reality and only disguise the inevitable facts. The Framework Agreement, however it is called, will lead Switzerland into the EU. This must be prevented by all means.

## Economiesuisse, are you little shitheads?

Beat Kappeler recently asked this question at the Swiss Autumn Conference. The reason for the question is Economiesuisse's position on the present framework agreement between Switzerland and the EU, which Econo-miesuisse is keen to sign quickly and without delay.

In order to answer this question, one concept needs to be clarified: What is a chickenshit? "Chickenshit" can have two meanings. Jokingly, it refers to a child who still pees his pants. A synonym would be "diaper pooper." The term swearword is used to describe a very scared person. A synonym would be "wuss".

Kappeler's whole question is: "Are you actually such little shits that you want to throw away your sovereignty because of some little difficulties? And Kappeler adds to his question with a statement: "You (Economiesuisse) are incompetent company and industry leaders, if you think that is worth it! Kappeler taps with it rather on "wusses", although a doddering guy can also be a wuss. But there is a small consolation for Economiesuisse: Kappeler's appeal is not only directed at Economiesuisse, but also at "official Switzerland".

Who is Economiesuisse?

Economiesuisse describes itself as the umbrella organisation of the Swiss economy. Economiesuisse represents around 100,000 companies from all sectors and regions of Switzerland, providing employment for around two million people. The exponents of Economiesuisse are the President Heinz Karrer and the Chief Executive Officer Monika Rühl. Both are supported by a board of directors consisting of more than seventy members, a twenty-member executive committee and around seventy-five employees.

And with Operation Libero, Economiesuisse also has a rather feminine, enterprising youth organisation at its side, at least when it comes to the framework agreement. The management of this complex organisation absorbs the

The time and energy of the two exponents is so precious that they are hardly ever seen among the parliamentarians in Bern.

Is Economiesuisse tired of home?

With so much original Swiss economic potential, the question arises: Is the Swiss powerhouse Economiesuisse tired of the framework agreement?

Answer: No, certainly not. Economiesuisse cannot be tired of home. Economiesuisse has no heating, is homeless. Economiesuisse sees itself as global. Economiesuisse does not represent the long-term interests of Switzerland, but the short-term concerns of global companies. There are people who think Economiesuisse is well on the way to becoming superfluous. This has already been achieved with the framework agreement.

#### **Is Economiesuisse blind?**

In a recently published interview with "Schweizer Monat", Monika Rühl, with

The contract states in Article 10, paragraph 2 that "an arbitral tribunal shall settle the dispute". Monika Rühl has read this sentence. The next sentence (Article 10, paragraph 3) Mrs. Rühl has either not read, or she is blind, or she is lying with her statement about the dispute resolution mechanism. This paragraph says that the arbitration tribunal must refer disputes to the Court of Justice of the European Union. This is the party court of the EU, i.e. the court of the other party in Switzerland. And then, for those- those who haven't got it yet, the sentence follows: "The ruling of the Court of Justice of the European Union is binding on the arbitration court."

Whether Economiesuisse is blind or lying is irrelevant in the end. Even blind people can lie. My guess is more likely to be a lie, in the sense of a statement that the sender knows to be untrue and which he makes with the intention that the recipient will believe it anyway. Trust in the umbrella organisation of the Swiss economy is not strengthened by such games.

#### **The decapitation of Switzerland**

When Kappeler accuses Economiesuisse of "immediately throwing sovereignty away", he is probably referring to the asymmetrical regulation of the dispute settlement mechanism, but probably even more so. The new guillotine regulation in the framework agreement is another element of the abandonment of sovereignty. A guillotine is a mechanical device for executing the death penalty by decapitation. The guillotine was mainly used in the French Revolution.

The new guillotine clause is provided for in Article 22 on the termination of the Agreement. If the Framework Agreement is terminated, all market access agreements concluded by Switzerland and the EU after the Framework Agreement comes into force will automatically be terminated. If the Framework Agreement is terminated, the five existing agreements of the first package would also be terminated within three months if no agreement was reached. The Framework Agreement, which Economiesuisse is selling as a strengthening of the bilateral path, would mean that Switzerland would fall behind the status quo if it were to be terminated. And the Free Trade Agreement, which will now also be covered by the Framework Agreement and the new guillotine, would make termination of the agreement completely impossible for Switzerland.

That would not only be the end of the bilateral path, but also the end of Swiss souvenir status.

#### **Yes, Economiesuisse are little shits**


